#### Elimination of the penny has minimal impact on your banking.

The Royal Canadian Mint stopped distributing the penny on February 4, 2013. Pennies already in circulation will keep their value and can still be deposited but will be phased out.

- Transactions by cheque, credit and debit card, and other electronic means won't be affected and will still be settled to the cent.
- Cash transactions will now be rounded to the nearest five-cent increment.
- To make a bill payment by cash, we recommend paying the exact amount (pennies can be used for payments) or rounding up to the nearest five-cent increment. For example, if you owe \$236.43 you'd round up to \$236.45. You would then have a \$0.02 credit with the biller.
